We can now almost instantly communicate with the Department NSOs and address any issues that might arise with a veteran's claim. The class was by Dept. invitation only but I can assure you the remaining CSOs will be brought up to speed on CMS in the very near future and then a request to give them authorization will be made.

I can't begin to tell you how proud I am of our Chapter's CSO work. Just this past Wednesday, Jan. 24th, we were visited on our claims day by a spouse who had just received approval of her DIC claim. This is a life changing event and the reason all of us do this work. We are proudly fulfilling DAV's promise to our veterans.

DAV's 80th annual State Convention will be held this May in Ocean City. All CSO's will attend to be recertified. There will also be classes on multiple topics allowing CSO's to expand our knowledge and better serve veterans.

February is right around the corner and we are in a Leap Year giving February an extra day. (Feb. 29th) That means I will have an extra day to sit around and do absolutely nothing. LIFE IS GREAT!

UNITED STATES NAVY SEALS



Navy SEALS are named after the environment in which they operate, the Sea, Air and Land, and are the foundation of Naval Special Warfare combat forces. They are organized, trained, and equipped to conduct a variety of Special Operations missions in all operational environments.

Although not formally founded until 1962, the modern-day U.S. Navy SEALS trace their roots to World War II. The United States Military recognized the need for the covert reconnaissance of landing beaches and coastal defenses.

The SEALS trace their heritage to various elite units in World War II, particularly to naval combat demolition units (NCDUs) and underwater demolition teams (UDTs) whose "frogmen" were trained to destroy obstacles on enemy-held beaches prior to amphibious landings in Europe and the Pacific.


